ACVREP Proposed Change to Eligibility Criteria: One-time Alternative Pathway to Eligibility

This initiative by ACVREP resulted in a huge response by COMS. Many comments were made on the AER O&M listserv and the AER FaceBook page. O&M Division Executive Committee members reached out to many COMS, read the many messages and developed the following comment which was sent to ACVREP on August 27, 2015.

AER O&M Division Executive Committee Comment for the ACVREP Alternate Pathway to Certification

While the Executive Committee of the AER O&M Division applauds ACVREP's efforts to expand the number of individuals who are certified as professionals teaching orientation and mobility to persons with vision loss, the alternate pathway that leads to certification identical to those professionals who have attended a university program, successfully completed a supervised practicum/internship, and passed the ACVREP examination cannot be supported by the O&M Division Executive Committee.

It is understood that ACVREP considers this as a first step towards establishing certified professionals who could then supervise those in training. However, university programs in international countries are declining rather than increasing. Future COMS in these countries would continue to have preparation that is inconsistent with established standards in the United States. Why would the professional O&M community in the US want to be compared with COMS in other countries who do not have the same preparation? The O&M Division does not sit in judgment over the quality of instruction being provided by O&M instructors in other countries, but does feel strongly that the same certification should not be granted to professionals who have not successfully completed university programs which require the same set of standards.

With the multitude of distance education opportunities and remote supervision for clinical experiences, there is no reason why international certification following the current standards in the United States cannot be met. Currently, the University of Pittsburgh has an agreement with New Zealand to provide coursework towards certification including an internship for individuals going into the O&M profession. Alternatively, a certification which differentiates the type of preparation many O&M instructors in other countries receive could be developed.

ACVREP is encouraged to work with AER, the O&M Division and individual O&M Specialists to explore ways that all can support quality services to individuals with vision loss around the world without degrading what ACVREP certification represents.

'To me, orientation and mobility provides individuals with all different abilities the necessary tools to make their own decisions, no matter how big or small; thus increasing their independence and creating a sense of control over one's life.'"

Advocacy and Legislation

Advocacy Alert

The Alice Cogswell and Anne Sullivan Macy Act (H.R. 3535)

On September 17, 2015, a comprehensive bill to reform the education of students who are deaf, hard of hearing, blind, visually impaired, and deafblind was introduced in the U.S. House of Representatives. Sponsored by Congressmen Matt Cartwright (D- PA 17th) and David McKinley (R-WV 1st), H.R. 3535 will amend the Individuals with Disabilities Education Act to address the unique needs of these populations. H.R. 3535 is named for two pioneers in the education of students with deafblindness; Alice Cogswell was the first student with deafness to be formally educated in the U.S. while Anne Sullivan Macy was the beloved teacher of Helen Keller. If enacted, the Cogswell-Macy Act will ensure that:

- every child who is deaf, hard of hearing, blind, visually impaired, or deaf-blind, regardless of whether they have additional disabilities, will be properly counted and served;
- each of a child's unique learning needs will be properly evaluated;
- states will engage in strategic planning to be sure that they can in fact meet each child's specialized needs;
- the U.S. Department of Education will do its part to hold states and schools accountable;
- students who are deaf will be served by qualified personnel;
- students who are blind will receive state-of-the-art services and skills supported through a new major national collaborative initiative addressing their unique learning needs;
- and students who are deaf-blind will have access to trained and qualified interveners.

There is much work to be done, if this bill is to be enacted into law. The bill needs to gain the sponsorship of many more House members, and it needs to be introduced in the Senate. AER and your MAER board urges all members to contact their Congressional members to ask them to sponsor this bill. Your voice matters! Below are some resources to help.

Tips and Tricks Corner


The Buncher

Because of visual impairment and/or motor problems, some children are unable to pick up an object again once they have let go of it. Since it is the repetition of grasping and letting go that lead to the ability of grasping and holding, the user will benefit from holding the object with the use of a buncher. This enables the user to grasp and let go whenever he/she wishes, to repeat the activity as many times as he/she needs, and to experiment with the duration of the grasp as well as the intervals between each repetition. Use of the buncher also permits the user's hand to touch the surfaces of the objects, which allows him/her to experience the tactile qualities of the items. The buncher can be used to hold/grasp a variety of items including spoons, brushes, massagers, toys, or other items.

The Buncher is made from two pieces of buttonhole elastic (average length used is 4 ¾ inches,) once piece of ½ or ¾ inch wide elastic and two buttons. Three buttons can be sewn on the elastic strap if the Buncher is being used in a classroom with various sizes of hands.

The solid elastic without buttonholes should be approximately 3 ½ inches long, spanning across the back of the user's hand. The buttonhole elastic should be long enough that it will loop around whatever object the user wishes to hold. "Fray Check," a liquid seam sealant by Dritz (available at most fabric stores) can be applied to the ends of the elastic to prevent fraying.
